

## **PUBLIC NOTICE FOR THE ASSIGNMENT OF A PROFESSIONAL CHARGE AS EXPERT IN INTERNATIONAL VETERINARY EQUIVALENCE AGREEMENTS NEGOTIATION POLICIES AND AUTHOR OF TRAINING CONTENTS FOR E-LEARNING**

In execution of the Deliberation n. 44, 21.01.2010, Istituto Zooprofilattico Sperimentale dell'Abruzzo e del Molise "G. Caporale" is launching a public notice for the assignment of a professional task as "Expert in international veterinary equivalence agreements negotiation policies and author of training contents for e-Learning". The assignment will have a duration of 12 months, renewable if necessary.

The participation is reserved to Italian, EU and non-EU citizens having – at the date of the application submission – the following qualifications:

1. Laurea Specialistica/Magistrale (or a qualification equivalent to this Italian title) obtained in Italy or in a country where an equivalence agreement for the study qualification admission is in force with Italy;
2. consolidated skills and competences in the framework of veterinary equivalence agreements negotiation and international audit on official food control systems implemented at national level, achieved through a specific experience at a National Competent Authority for food safety;
3. proven experience as food inspection officers trainer;
4. communication, negotiation, and mediation skills and competences;
5. excellent knowledge of written and spoken English language, possibly mother tongue.

Applications for participation in this notice, written in Italian or English on plain paper and signed by the candidate, must be sent, penalty of exclusion via the postal service with return receipt or authorised courier, **no later than 10 february 2010**; the Postal Service stamp date or the courier receipt date will attest the candidate submission within the deadline.

Applications must be addressed to the Director of Istituto Zooprofilattico Sperimentale dell'Abruzzo e del Molise "G. Caporale" via Campo Boario 64100 Teramo (Italy). Application must include a professional and educational detailed curriculum in English or Italian language, written on plain paper, duly dated and signed by the applicant, the adoption of the EUROPASS form is expected. Applications with no CV attached will not be accepted.

The professional task will be awarded after a comparative evaluation of candidate curricula, performed by an ad hoc Committee.

The curricula comparative evaluation could be integrated by personal interviews with the candidates having the most relevant CVs, in order to deepen each candidate competence and experience, if the Committee deems it appropriate.

In case of receiving just one application, after the internal Competent Office verification on the admission requirement possession, Istituto Zooprofilattico Sperimentale dell'Abruzzo e del Molise "G. Caporale", once acquired the Director's opinion, reserves the right to assign or not the task.

A specific contract between the Institute and the person concerned will contain the discipline of the assignment which will be given in response to this notice.

The contract will define the specific subject of the collaboration, its duration, the amount due and any other legal, economic, taxation and social security aspects. Furthermore, the contract will expressly specify that the person in charge will execute her/his professional performances towards this Institute, without any exclusivity obligation or subordination commitment. The person in charge will also take into

account the general instructions and guidelines from the Institute Direction. The person in charge will periodically refer the results to the Institute management, in order to make possible the coordination between the offered performances and the specific goals pursued.

The candidate, whom the professional task will be assigned to, as result to this notice, will start her/his activity at the date established by this Institute.

In compliance with the D.Lgs. n. 196 of 30 June 2003, the personal data provided by the candidates will be collected and processed only with the purposes of the selection management procedure, and in accordance with the terms of the current legislation on the management of the tasks that will be assigned on the basis of the list determined as result of this notice.

For proper reasons, this Institute reserves the right to modify, extend, suspend or revoke all or part of the present notice.

The participation to this notice entails the implicit and unconditioned acceptance of everything established in it.
